Terms & Conditions 2009/2010**

Entitlement

One card per:

- **Full-time** resident or resident family in the Hurunui District.
- Individual ***Land** ratepayer **listed on the Hurunui District Council** rating roll and their *family*. **Joint Ratepayers** may nominate up to three *families* for the Annual Swim Pass. Additional *families* over and above the first *family* will be **required** to pay the full normal Annual Swim Pass rate.
- **Company or Trust** listed on the Hurunui District Council rating roll. Up to **three families** may **purchase** the Annual Swim Pass. Additional *families* over and above the first *family* will be required to pay the full normal Annual Swim Pass rate.

**Land* Ratepayers only, no Water Rates only properties.

For the purpose of the Ratepayer and Residents Cards a 'family' consists of two adults and their dependant children 18 years and under.

Conditions

The Ratepayer and Residents Annual Swim Pass is for the use of the family or person named on the card only and is not transferable.

For the card to be valid a current photograph of the individual family members or person named on the card must be taken and stored digitally by Hanmer Springs Thermal Pools & Spa.

The card must be swiped through the card reader at the Reception counter to receive entry to the Thermal Pools.

Misuse of the Annual Swim Pass will result in the card being revoked.

Card replacement is at the discretion of Hanmer Springs Thermal Pools & Spa and attracts a \$15 service fee.

The Annual Swim Pass can be purchased at any time for \$174 or \$129 prior to 18 December 2009 and is valid to 31 December 2010.

Validity

Residents Cards

Residents will be required to **purchase an Annual Swim Pass each year** by completing a new Residents Card application and by providing proof of residency.

Ratepayers Cards

Ratepayers will be required to re-validate their Annual Swim Pass each year by **purchasing an Annual Swim Pass each year.**

Companies & Trusts

Companies & Trusts will be required to provide **written confirmation of the nominated 'family or families'** authorised to receive the Ratepayers Annual Swim Pass and by **purchasing an Annual Swim Pass each year.**
